### 1. Charitable Donation Criteria

Before submitting a request please read the following:

- All requests should be made at least 8 weeks prior to the date the donation is required with the exception of urgent applications.
- Those submitting requests must complete this Giving Glasgow application form and provide information on: how the donation would benefit the individual/organisation, how the donation would help the local community and how the donation would help tackle social or financial exclusion.
- If the request is on behalf of an organisation, the person submitting the request must have authorisation from the organisation to do so on their behalf.
- The organisation must agree to provide feedback on the impact of the donation if requested by the credit union.
- The organisation must agree to take part in, and provide reasonable notice of any PR and marketing opportunities related to this donation.
- Each organisation is only permitted to make one donation request each year.
- All applications will be reviewed and accepted at the sole discretion of Glasgow Credit Union and a response will be provided within 8 weeks.
- Glasgow Credit Union will not support any organisation where involvement would bring any disrepute or detrimental PR to the organisation.
