

Giving Glasgow application form

- Charitable and voluntary groups based within the above postcodes, where activities or events are undertaken on behalf of good or charitable causes.

1. Charitable Donation Criteria

Before submitting a request please read the following:

- All requests should be made at least 4 weeks prior to the date the donation is required (with the exception of urgent applications).
- To be considered for a donation, you must fully complete this form with the required information.
- The application must show how the donation will make an impact in the local area.
- If the request is on behalf of an organisation, the person submitting the request must have authorisation from the organisation to do so on their behalf.
- The organisation must agree to provide feedback on the impact of the donation.
- The organisation must agree to take part in any marketing activity related to this donation. If the application comes from a FK, KA or ML postcode, a photo must be provided if requested.
- Each organisation is only permitted to make one donation request per year, with a maximum of two donations.
- All applications will be reviewed and accepted at the sole discretion of Glasgow Credit Union and a response will be provided within 4 weeks.
- Glasgow Credit Union will not support any organisation where involvement would bring disrepute or cause reputational damage to the organisation.
